1. UK Media

- Please supply at least three examples of coverage, where possible coverage should be devoted to the FIA World Endurance Championship.

2. UK Photographers

- Publication photographers must supply a sample of the publication (PDF) and/or link.
- Photographers must supply at least three examples of coverage, where possible coverage should be devoted to the FIA World Endurance Championship. The applicant must be clearly credited.
- Freelance photographers must apply for accreditation via their own agencies/media.
- Photo agencies must supply confirmation of use of images to relevant publication with the relevant credits.
